## From your Servant Leaders:

**January 4, 2018**

If we only know what we read or see in the media, last year was pretty bad and it is only going to get worse. I guess gloom and doom sells more than sweetness and light. I choose to see the positive aspects of today and tomorrow, so here are a few things that can give us hope as Vincentians for the year ahead.



**Jobs.** Unemployment is down for everyone and especially so for Hispanic and Black groups. We recognize that for many people the best path out of poverty is a job, so this is a very encouraging trend. Perhaps even more encouraging is that non-college degree jobs are in high demand. Every job is potentially a family that supports itself and doesn't need our help, preserving our resources for those who need us most.

**Wages.** Correlated with the job demand is higher wages. While the effect of mandated minimum wage levels will be debated, the scarcity of jobs in some categories certainly will elevate wages simply to attract workers. The people in need we work with often are employed but under-employed. So we look forward to their earning higher wages next year.

## **Residents in Puerto Rico and the U.S. Virgin Islands still struggling after Fall Hurricanes**

Hurricane Maria made its first landfall on the Caribbean island nation of Dominica on Monday, September 18, 2017 as a Category 5 storm with winds howling up to 160 mph. Days later, the storm devastated the U.S. territory of Puerto Rico, according to CNN.

The U.S. Virgin Islands were dealt two devastating blows when they were hit hard by Hurricane Irma and then Hurricane Maria just 14 days later. According to the New York Times, Maria drowned and destroyed what Irma did not, leaving the Islands in ruins.

SVdP Disaster Services are still needed! The SVdP Disaster Services Corporation deployed a team of 14 volunteers to Puerto Rico from Dec. 2-9, 2017. While there, they hosted two Parish Recovery Assistance Centers (P-RACs) where they served families that had been devastated by Hurricanes Maria, Irma and poverty.

Two more P-RACs are being planned to open in January 2018 in San Juan, Puerto Rico. A deployment to assist in the U.S. Virgin Islands is being considered for February 2018. Both the U.S. Virgin Islands and Puerto Rico are still declared under a State of Emergency.

While you may not be able to be on the ground in the impacted areas, you can help with the extensive recovery effort from home. Your contribution is critical to meeting the needs of those of who have lost everything!

**Q: How should funds from a closed Conference be used?**

A: The intent for the use of funds from a Conference that has closed is to use the money collected to help the poor in that particular area where the Conference once

existed. Upon closure all funds are directed to the next highest Council; they are not to be transferred to the parish or diocese. The District Council should make every effort to serve families in that area using the resources of the closed Conference. If other Conferences are serving the area, then the Council should specifically reimburse that Conference or Conferences individually, and per neighbor in need case, based on their assistance to families in that area. Conferences who step up to serve those in the closed Conference community should not be given the money upfront. Every effort should be made to use the resources of a closed Conference collected for families in the community in which it was originally donated.

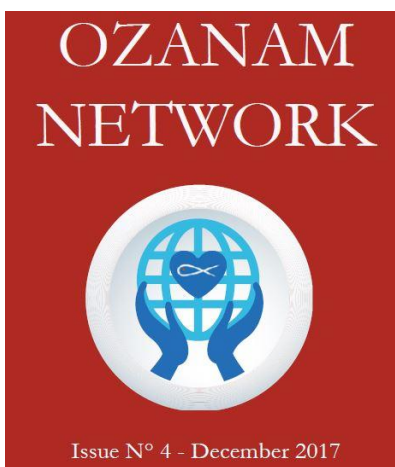

## 2017 Annual Reports Revised Due Dates

The new and improved 2017 reports have been streamlined and now require 50 percent less data collected! Hardcopy forms are available now at:

Given some technical difficulties with our new database development, the integrated annual report functionality is temporarily impacted.

We are working hard with the vendor to resolve these problems; meanwhile, the online annual reporting capability will not be accessible. At this time we anticipate the online reporting capability to be available in January 2018.

**As a result the online annual report data entry deadlines have been extended as follows:**

### **Thrift Store & Special Works Annual Reports:**

The owner (Conference or Council) of the store or special work has to do these reports first since the owner needs the store and special work information for their (Conference or Council) report.

## 501 (c) (3) Tax Exemption Notice

**Good News!**

**Effective January 1, 2018, the IRS reduced the IRS Form 1023 application user fee from \$850 to \$600 and the group ruling application fee from \$3,000 to \$2,000.**

In October of 2016, the Society began a two-year plan to transition all Councils and Conferences (except Isolated Conferences) off the Society's Section 501(c)(3) Group Ruling with the IRS (GEN 5496).

As the deadline approaches, October 1, 2018, we take this opportunity to remind leadership of the need to take action to plan a smooth transition to the tax exempt process your Council will undertake. The options contain step-by-step instructions for you to implement the necessary changes for your Conference and/or Council. We recommend Conferences and

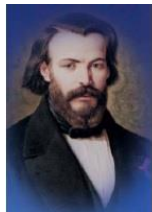

## The Friends of the Poor® Grant Program is looking for new Committee Members to review Proposals



Over the last couple years the program's annual awards have grown from \$80,000 to over \$250,000. The program consists of a simple grant application which is limited to Conferences. The maximum amount that can be awarded is \$5,000. The main interest areas are emergency assistance and systemic change. The Committee is composed of Vincentians from all eight regions. The commitment is for one year, and then annual renewals by the FOP Grant Review Committee chairperson.

**FOP Grant Committee Member Duties:**

1. There are four conference calls a year to review the grant applications (lasting about 45 minutes each).
2. Each committee member is sent the grant applications and spreadsheet well in advance of the review committee conference call.
3. Each committee member is asked to review and rank each of the grant applications using a standard scoring method.
4. During the conference call, the top ranked applications are reviewed in detail and the committee decides on the award amounts.
5. Review committee members are asked to recuse themselves in reviewing projects from their Conference/Council.

This is a hope based in the truth of God's love, our on-going support and their own effort and dreams for the future.

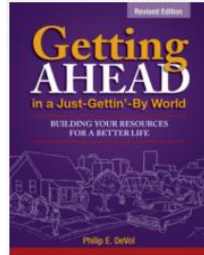

### **Cancer pushes older Couple to Brink of Insolvency; Nonprofit lends a Hand**

PHOENIX, AZ:

By all accounts, Alvin and Carolyn Spearman were an American success story.

They were comfortably headed towards their retirement years when they moved to the Valley from Chicago in 2001. Carolyn, with decades of experience as a nurse, found a job in the healthcare system and Alvin, an Army veteran with years of marketing experience, found gratifying work counseling vets in how to navigate the often-confusing VA benefits system.

But a series of life events put them on the edge of insolvency. It started four years ago when Carolyn's mother was diagnosed with lung cancer in Chicago. To help, the couple went back to the Windy City. With her mother's condition deteriorating quickly, Carolyn learned that holding a job wasn't possible. At the same time, the couple was informed that health insurance wouldn't completely cover all the treatments. So, they paid the enormous co-pays and out-of-pocket expenses themselves.
